### CHAMPVA Supplement Insurance Plan - How the ... - Tricare

CHAMPVA allows caregivers to access VA health care services and private doctors who contract through CHAMPVA. It is an insurance program, so copayments might apply. CHAMPVA is a second payer to other health insurance programs, including Medicare, which means your existing insurance has to pay first. Then, CHAMPVA may pick up remaining costs.

The health programs TRICARE and TRICARE for Life are the two main programs provided to active duty members and most retired military personnel and their dependents. The programs' previous name – the Civilian Health and Medical Program of Uniformed Service (CHAMPUS) – is part of the confusion with the VA's health program, CHAMPVA.

### TRICARE/CHAMPVA Supplement Insurance | AMS Insurance Program

Due to the similarity between CHAMPVA and the Department of Defense (DoD) TRICARE program (sometimes referred to by its old name, CHAMPUS) the two are often mistaken for each other. CHAMPVA is a Department of Veterans Affairs program whereas TRICARE is a regionally managed health care program for active duty and retired members of the uniformed services, their families, and survivors.

### TRICARE AND CHAMPVA - Cheyenne VA Medical Center

If you are involuntarily disenrolled from TRICARE or CHAMPVA, you are eligible to immediately reenroll in the FEHB Program. Your request to reenroll must be received within the period beginning 31 days before and ending 60 days after your TRICARE or CHAMPVA coverage ends. Otherwise, you must wait until Open Season.

CHAMPVA Eligibility. To be eligible for CHAMPVA, you cannot be eligible for TRICARE, and you must be in one of these categories: The spouse or child of a Veteran who has been rated permanently and totally disabled for a service-connected disability by a VA regional office.
